The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 21.01.2015 by the undersigned in presence of Shri K.N.Pant, Mine Manager

Rule No.	Nature of violation observed in detail
13(1):	The mining operations are carried out in violation of following provisions of approved modified Mining Plan (approved on 21.02.2014): - (i) In Para 5.0 during the in year 2014-15 the production of lime stone was proposed 60,000 tonnes but actual production achieved 73,413.3 tonnes up to 31 <sup>st</sup> Dec. 2014 for the year 2014-15.
45(1) (a):	Monthly return for the month of December 2013 has not been submitted to this office.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
04. You are advised to rectify the above violations immediately and intimate the position to this office on letter pad signed by the owner within 45 (forty-five) days from the date of issue of this letter.
