The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mentioned mine with respect to the Mining Plan of above mentioned mine was approved vide this office letter No-MP/Katni/Limestone/MPLN/R-36/2014-15 dated 22.12.2014 incorporating the proposals of working from 2015-16 to 2019-20 during the inspection by Shri Sanjay M. Girhe, Regional Mining Geologist on 20.03.2021 in presence of Shri. Manoj Kumar Roy, Mines Manager, as detailed under-

Rule11 (1)	According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt. pursuant to the provisions to clause (b) of Sub Section (2) of Section 5 or approved by the competent authority of the Atomic Minerals Directorate for exploration and Researching respect of minerals specified in Part B of the First Schedule of the Act where the grade of such atomic minerals is equal to or above the threshold value limit declared under schedule-A of the Atomic Mineral Concession Rules 2016
	i) During the year 2019-20 total 6600 M <sup>3</sup> top soil generation and 16,420 M <sup>3</sup> OB/mine waste generations were proposed but against to these proposals, only 1000 M <sup>3</sup> top soil and 9500M <sup>3</sup> OB/waste generated during the year which is very much on lower side.
	ii) Further, as per Modified Mining Plan approved vide this office letter No-MP / Katm / Limestone/MOD-36/2019-20 on dtd 29.06.20 for the proposal period from 2021-22 to 2024-25, No boreholes were drilled against the proposal of 02 nos. of core boreholes during the year 2021-22.

	The plans & sections were not found updated on quarterly basis as required under this rule and not maintained at mines site office.

04. You are therefore advised to rectify the above violations immediately and intimate the position to the office within 45 (Forty Five) days from the date of issue of this letter.
