The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 21.02.2015 by the undersigned in presence of Shri N.S.Rana, Mine Manager

## Nature of violation observed in detail Rule No.

The mining operations are carried out in violation of following provisions of approved Scheme of 13(1): Mining (approved on 06/12/2012): -

(i) Actual production achieved are higher side as proposed:

Year	Proposed Production	Actual Production
2012-13	16523 tonnes	19272 tonnes
2013-14	19755 tonnes	36869 tonnes /

It construes that during the year 2012-13 and 2013-14 production are 17% and 87% respectively

higher side against the proposed production.

(ii) In Para 5.0 It was proposed that mining shall be carried out by formation of benches from 3 height of each bench but the orientation & height of the benches are not as per plate no. 09 of the approved scheme of mining.

In this connection, it is brought to your notice that the above violations constitute an offence punishable under 02. Rule 58 of MCDR, 1988.

The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 03.

1988 is not found satisfactory.

You are advised to rectify the above violations immediately and intimate the position to this office on letter pad 04. signed by the owner within 45 (forty-five) days from the date of issue of this letter.
