Rule No. Nature of violation observed in detail

13(1):

The mining operations are carried out in violation of following provisions of approved Scheme of Mining (approved on 06/12/2012): -

(i) Actual production achieved are higher side as proposed:

Year	Proposed Production	Actual Production	
2012-13	16523 tonnes	19272 tonnes	
2013-14	19755 tonnes	36869 tonnes	

It construes that during the year 2012-13 and 2013-14 production are 17% and 87% respectively higher side against the proposed production.

- (ii) In Para 5.0 It was proposed that mining shall be carried out by formation of benches from 3 height of each bench but the orientation & height of the benches are not as per plate no. 09 of the approved scheme of mining.
- In this connection, it is brought to your notice that the above violations constitute an offence punishable under 02. Rule 58 of MCDR, 1988.
- The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 03. 1988 is not found satisfactory.
- You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to 04: why you should not be prosecuted for the above offences.
