Sub: Violation of provisions of MCDR, 2017 in respect of Nandavaram Limestone Mine of Sri S.VenkataRami Reddy over an extent of 2.202 ha situated in Survey no 510 of Nandavaram(V) Banaganapally(M) Kurnool Dist. Andhra Pradesh state

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated during inspection of the above mine on 28.6.2017 by Sri A. Prabhakara Rao Asstt. Mining Geologist of this office accompanied by Sri P. Loki Reddy your representative.

Rule No.	Nature of Violation
11(1)	The Scheme of Mining for the above mentioned mine was approved vide letter no .AP/KNL/MP/L.ST-60/HYD on 28.05.2014 for 5 years period i.e. (2012-13 to 2016-17) and valid up to 31.03.2017. and there after there is no approved Scheme of Mining / Review of Mining Plan. Since you have no approved mining proposals in form of Review of Mining Plan for your above mentioned mine, it is evident that the mining operations are not being carried out in accordance with the approved Review of Mining Plan.
11(4)	The holder of a mining lease shall submit the mining plan to the competent authority for review at least one hundred and eighty days before the expiry of five years period for which it was approved on the last occasion, for mining operations for a period of five subsequent years.” The proposals made in the earlier document approved vide letter no .AP/KNL/MP/L.ST-60/HYD on 28.05.2014 was expired on 31.03.2017, So far no mining proposal in the form of review of Mining plan has been submitted in this office..

02 In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017.

03 You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
