Sub: Violation of provision of Mineral Conservation and Development Rules, 2017 in respect of Takalapalli Limestone Mine (38APR09002) over an extent of 122.28 ha. of Takkallapally Village, Palakurthy Mandal, Peddapalli District., Telangana state.

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in your above mine during the inspection on 02.09.2021 in the presence of Shri. Subhashish Bose, Mine Manager & Shri. S.Thirupathi, Geologist.

Rule No.	Nature of Violations observed
11 (1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5. Mining operations are not carried out in accordance with the proposals given in approved Modified Mining Plan vide letter no. AP/KRM/MP/Lst-4/Hyd dated 17.01.2019 to the extent indicated below. It was proposed to plant 385Nos. saplings 2020-21. However during inspection it was noticed that plantation was not carried out as per the proposal.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Further, inability to comply the provision of Rule 11(1) is liable for suspension of mining operations under 11(2) of MCDR, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
