The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 07.12.2019 by the undersigned in presence of Shri L.S. Pohkarna, Mine Manager:

Rule 11(1)	The mining operations were carried out in violation of following provisions of approved
	Modified Mining Plan for the year 2018-19: -
	(i) During the year 2018-19 exploration was proposed by drilling of 08 bore holes (800m) but no such drilling has been carried out.
	(ii) During the year 2018-19 sugrade dumping was proposed between section lines ML3 to ML5
	but actual subgrade dumping has been carried between section lines ML2 to ML5.

- In this connection, it is brought to your notice that the above violations constitute an offence punishable 02. under Rule 62 of MCDR, 2017.
- The mining operation can be suspended under rule 11(2) of MCDR, 2017 if compliance of rule 11(1) of 03. MCDR 2017 is not found satisfactory.
- You are advised to rectify the above violations immediately and intimate the position to this office within 45 04. (forty-five) days from the date of issue of this letter.
