विषय : Violation of provisions of Mineral Conservation & Development Rules, 2017 in respect of your **Sajit Siliceous Earth Mine** (M.L. 161/2013, Lease area 4.3630 Hect.) in Jaisalmer District of Rajasthan State.

महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 05.03.2020 by the undersigned in presence of Shri Ramswaroop Meghwal, Mine Owner:

Rule No.	Nature of violation observed in detail
Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Mining Plan(Approved on 03.03.2015): - (i) Exploration was proposed by digging 03 trail pits during the first year of approved mining plan i.e. during the year 2016-17 but no such exploration has been carried out. (ii) Bench height & width have not been maintained as per approved proposals. (iii) Mining excavation was proposed from Northern Side to Southern side but during the inspection it was observed that excavation has been carried out in the central part of the lease area.
26 (2)	A yearly report to be submitted before 1 st July of every year setting forth the extent of protective and rehabilitation works carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office for the year 2018-19.
45(5)(b)	A monthly return which shall be submitted before the tenth day of every month in respect of preceding month in electronic form along with a signed print copy of the same if it is not digitally signed, but till date you have not submitted the monthly returns of your mine in respect of August 2019 to March 2020.
45(5)(c)	An annual return which shall be submitted before 1 st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same if it is not digitally signed in the prescribed form but till date you have not submitted the annual return of your mine for the year 2018-19.

02. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों के उल्लंघन की अनुपालना नहीं होने पर खनिज संरक्षण एवं विकास नियमावली 2017 के अन्तर्गत:

- (क) आपकी खदान की सारी संकियाएं बंद की जा सकती हैं।
(ख) आपके विरुद्ध अभियोग दायर किया जा सकता है।
(ग) खनन पट्टा खंडन की अनुसंशा की जा सकती है।

03. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैंतालीस) दिनों के भीतर इस कार्यालय को प्रेषित करें।
