महोदय,

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 06.12.2019 by the undersigned in presence of Shri Somnath Banerjee, Mine Manager:


Rule No.	Nature of violation observed in detail
Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Review of Mining Plan(Approved on 26.03.2018): - (i) Ramp/ haul road designed in Northern side of existing mine pit which was not proposed in approved review of mining plan. (ii) During the year 2018-19 total 1500 m ³ top soil generation was proposed but actual 14016 m ³ top soil was generated.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017 and in case of non compliance of the above rules following action may be initiated under MCDR, 2017:

- (a) Mining operations may be suspended under rule 11(2) of MCDR, 2017.
(b) Prosecution may be launched against you.

03. You are advised to rectify the above violations immediately and intimate the compliance to this office within 45 (forty five) days from the date of issue of this letter
