The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection made on 18.10.2019 & 19.10.2019 by the undersigned in presence of Sh. G. R. Bishnoi, Mine Manager & Sh. Narendra Menaria, Sr. Manager(Geology).

Rule 11(1)	The mining operations are carried out in violation of following provisions of approved Scheme of mining
	(Approved on 06.04.2015): -
	1) Mine development in Nagri Pit between grids E2800 to E3050 & N3170 to N3380 has been
	carried out up to year 2018-19 which was not proposed.
	2) Mine development in Jai pit has not been carried out as per approved proposal.
	3) Large quantities of boulders were lying all around in Surjana, Nagri & Jai pits.
	4) ROM production has been raised 2857780 tonnes as reported under item 4.2(B) (i) of Part V in annual
	return 2018-19 against the Total Environment Clearance of 2824000 tonnes of the mine (2800000 tonne
	EC of Jai ,Surjana & Nagri Pits and 24000 tonne EC of Bherda Pit).
Rule 31(4)	Plans & sections required to be kept under rule 32 have not been maintained up to date within three months.
45(7)	In annual return 2018-19 following discrepancies were observed:
	 During the year 2017-18 total ROM Limestone production has been reported 2857780 tonnes under item 4.2(B) (i) of Part V whereas in part VI of annual return 2018-19 ROM production as well as dispatch quantity have been shown 2794980 tonnes.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of MCDR, 2017 and in case of non compliance of the above rules following action may be initiated under MCDR, 2017:

(a) Mining operations may be suspended under rule 11(2) of MCDR, 2017.

- (b) Prosecution may be launched against you.
- 03. You are advised to rectify the above violations immediately and intimate the compliance to this office within 45 (forty-five) days from the date of issue of this letter
