Violation of provision of Mineral Conservation and Development Rule, 2017 in respect of your Sub: Bhinyasar Silicious Earth Mine (M.L. Number 16/93) in Jaisalmer District of Rajasthan State.

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found to violate in your above said mine during inspection on

28/01/2020 by undersign in presence of your good self:	
Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Review of Mining Plan approved vide letter dated 22/03/2017 to the extent given below:
	(1) Plantation work as proposed along the boundary line R to S for the year 2017-18 and 2018-19 has not been carried out.
26(2)	The yearly report for the extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the competent authority for the year 2018-19.
31(4)	As per rule plans and sections are required to maintain upto date within three months. During inspection it is observed that Plans and sections are not maintained up to date as required under the rule.
33	The plan and sections as mentioned under rule has not been submitted to the Regional Controller of Mines, Ajmer on or before the 30th day of June.
45(7)	On examination of annual return for the year 2018-19 following discrepancies have been observed.
	(i) Part I, Para 12: The information of land use furnished under para is not matching with the actual land use.
	(ii) Part V, Section 3: The updated position of the Reserve and resource furnished as on 01/04/2019 is not in synchronization with approved document dated 22/03/2017.
	(iii) Part V, Section 4: Quantity of total overburden/waste removal has not been furnished. Further, cumulative quantity of overburden/waste backfilled has not been furnished.
	(iv) Part V, Section 4 (Mineral Reject): It has been reported that there is no mineral reject generation during the year 2018-19. However, a quantity of 1640 tonnes has been furnished under mineral reject generation.
-	(v) Part VI: ROM production has been reported as of 12450.00 tonnes and after adding same in opening stock, closing stock of 17419.71 tonnes has been furnished. In the table of grade wise production, again production of 12450.00 tonnes has been furnished. Hence, it is
-	perceived that entire ROM is processed and same should not be consider for estimation of closing stock of the ROM.
	(vi) The Ex-mine price has been furnished as Rs. 250.00 per tonnes and the cost of production has been furnished as Rs. 469.00/- per tonnes. Hence the details of deductions used for computation of Ex-mine price under section 4 of Part-VI to be furnished.
