महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 09/10/2019 by the undersign in presence of Shri Pankaj Kumar, Mine Manger and Sri Mohammad Siddik, Geologist of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modification in Review of Mining Plan approved vide letter number 584(4)(3)(1628)/2016/RCOM-AJM dated 05/05/2016 to the extent given below:
	(1) The individual terrace height of the Screen Reject dump was approved to maintain 10 meter. However, during inspection height of the terraces has been observed more than 10 meter or around 15 to 20 meters.
	(2) The stripping ratio has been proposed to 1:0.38 CuM/CuM for the year 2018-19, however, stripping ratio achieved during the year 2018-19 was 1:0.59 CuM/CuM.
12(1)	Adequate retaining wall and garland drain has not been provided in the interest of protection of environment along the tow of the Screen Reject dump to arrest surface runoff.
45(7)	On examination of annual return for the year 2018-19 following discrepancies have been observed. (1) During Mine inspection generation of Limestone ROM was reported to 3776909.00 MT,
	however, in part VI of annual return for the year 2018-19 same has been furnished as 3321025.00 MT.
	(2) Mineral reject quantity of 455884.00 MT has been mentioned under part-V, section-04 of annual return. However, it appears on examination of part VI of annual return that no additional mineral/material is generated from ROM (as quantity furnished for ROM and grade wise production is same).
	(3) Part V, Para 4.2: The quantity of waste disposed of in external dumps has not been furnished for the year 2018-19.

02. It is brought to your notice that above violations of MCDR, 2017 constitutes an offence punishable under Rule 62 of MCDR, 2017.

- 03. Inability to comply the provision of MCDR, 2017 following action may be initiated against you:
- (i) order suspension of all mining operations in the mine.
- (ii) take action to initiate prosecution under these rules;
- (iii) recommend termination of the mining lease.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
