বিষয়: Violation of provision of Mineral Conservation and development rule 2017 in respect of your Bagawas Iron Ore in Jaipur district of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 03/10/2019 by the undersign along with Sri Rajani Kanta Rautaray, AME in presence of Sri Sushil Kumar Agrawal (Lessee representative) and Sri Santu Lal Saini, Mine Manager of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modification in Review of Mining Plan approved vide letter number 584(4)(3)(1747)/2018/RCOM-AJM dated 13/07/2018 to the extent given below: (1) The height and width of the benches has been proposed to 6 meters and 6 to 8 meters respectively. During inspection, height of the benches has been observed more than 6 meter. Also no systematic benches have been formed as proposed in above approved document. (2) The dumping of waste/OB has been proposed between grids N35-N75/E145-E180. However, dumping of the waste has been observed over old waste dump between grids around N135-215/E05-45. (3) On examination of reclamation plan for the year 2018-19, it is observed that proposal of plantation has been given near lease boundary pillar 'D'. Plantation work has not been carried out as per proposal.
12(1)	It is observed during inspection that Mineral deposit has not been developed systematically as benches have not been formed according to approved document. Further, Retaining wall and garland drain has not been provided along the tow of the waste dump to arrest surface runoff in the interest of protection of environment.
26(2)	Yearly report on extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan has not been submitted for the year 2018-19 to the Regional Controller of Mines, Ajmer.
31(4)	As per rule plans and sections are required to maintain upto date within three months. During inspection it is observed that Plans and sections are not maintained up to date as required under the rule.

- As per rule holder of the Mining Lease should maintain the records of expenditure incurred towards the mine closure activities these shall be made available at all reasonable times to the authorised officer for inspection. During inspection records of plantation carried out during the year 2018-19 has not been made available for inspection.

 - (ख) आपके विरूध्द अभियोग दायर किया जा सकता है।
 - (ग) राज्य सरकारा को खनन पट्टे की समप्ति की सिफारिश।

03. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
