The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found to violate in your above said mine during inspection on 07/01/2020 by undersign in presence of your good-self and Sri Rajesh Kumar Naval, Mining Engineer of your Mine:

Rule	Status and extent of violation
26(2)	As per rule the holder of mining lease shall submit to the competent authority a yearly report every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan. The mentioned report for the year 2018-19 has not been submitted to the competent authority i.e. Regional Controller of the Mines, Ajmer.
33	The plan and sections mentioned under rule has not been submitted to the Regional Controller of Mines, Ajmer on or before the 30th day of June.
45(7)	On examination of annual return for the year 2018-19 following discrepancies have been observed. (i) Part I, Para 12: The details of the land use furnished as on 01/04/2019 is appears to be incorrect. (ii) Part IV: During inspection it reported that 6000 tonnes of overburden has been removed during the year 2018-19. However, a quantity of 4020 tonnes has been mentioned in the annual return for the year 2018-19. (iii) Part V, Section 3: The position of the Reserve and Remaining Resource of Siliceous Earth has been furnished as Nil or 0. (iv) Part V, Section 4 (Mining Operation during the year), para 4.2: Total quantity of Overburden/Waste removed during the year has not been furnished. Further, the cumulative backfilled waste quantity furnished is incorrect as quantity of 4020 tonnes has been furnished under during the year backfilled quantity and quantity of 3850 tonnes has been furnished under during the year backfilled quantity.
	under during the year backfilled quantity, which is less than the year wise backfilled quantity. (v) Part V, Section 4 (Mineral Reject), para 4.2: During inspection it has been reported that there is no mineral reject generation during the year 2018-19. However, a quantity of 500 tonnes has been furnished under mineral reject generation.
