The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found to violate in your above said mine during inspection on 17/03/2020 by undersign in presence of your lessee representative Sri M.M. Atre:


Rule	Status and extent of violation
11(1)	Review of Mining Plan was approved vide letter number 584(4)(3)(1786)/2019 RCM-AJM dated 02/05/2019 with following conditions: Condition Number (viii): The authenticated coordinates of mining lease boundary pillars re-verified by DMG, Rajasthan will be submitted to this office within a period of 60 days from the date of approval. On verification of the office records it has been observed that authenticated coordinates of mining lease boundary pillars re-verified by DMG, Rajasthan has not been submitted to this office.
26(2)	The yearly report for the extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the competent authority for the year 2018-19.
45(7)	On examination of annual return for the year 2018-19 following discrepancies have been observed. (i) Part I, Para 12: The details of the land use has not been furnished. (ii) Part IV, Para 2 and 3: The quantity of total production during the year and overburden removed has not been furnished in the relevant para. (iii) Part V, Section 4 (Mining Operation during the year), para 4.2: Total quantity of Overburden/Waste removed during the year has not been furnished. (iv) It has been reported during the inspection that a quantity of 105 tonnes of waste has been generated during the year. However, same has not reported in the relevant paras of the annual return.

02. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों का उल्लंघन की अनुपालना नहीं होने पर खनिज संरक्षण एवं विकास नियमावली, 2017 के अंतर्गत :

- आपकी खदान की सारी संक्रियाएं बंद की जा सकती है।
- आपके विरुद्ध अभियोग दायर किया जा सकता है।
- राज्य सरकार को खनन पट्टे की समिति की सिफारिश।

03. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैंतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
