Sub: Violation of provision of Mineral Conservation and Development Rule, 2017 in respect of your Sheopura Kesarpura Limestone Mine in Ajmer District of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found to violated in your above said mine during inspection on 22/08/2019 by the undersign in presence of your good self and Shri T.K. Dhelawat, Mine Manager of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modification in Review of Mining Plan approved vide letter number 584(4)(3)(1710)/2017/RCM-AJM dated 16/11/2017 to the extent given below: (1) An area of 2.4 hectare was proposed to rehabilitate by the way of plantation during the year 2018-19. However, it has been reported that only 0.6 hectare area has been rehabilitated. (2) Proposal for construction of retaining wall of 180 mts and 600 mts around waste dump-01 and waste dump-02 respectively has been envisaged. However, no retaining wall has been constructed.
45(7)	On examination of annual return for the year 2018-19 following discrepancies have been observed. (1) In part II A, Capital Structure, Interest paid during the year has been reported. However, in cost of production part, interest paid per tonne is reported as NIL.
47	As per rule the holder of a mining lease shall send intimation in Form I within fifteen days after the commencement of borehole to a depth exceeding ten meters from the surface. It is observed that Form-I has not been submitted for all drilled bore holes.


02. It is brought to your notice that above violations of MCDR, 2017 constitutes an offence punishable under Rule 62 of MCDR, 2017.

03. Inability to comply the provision of MCDR, 2017 following action may be initiated against you:

- (i) order suspension of all mining operations in the mine.
- (ii) take action to initiate prosecution under these rules;
- (iii) recommend termination of the mining lease.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
