The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 07/10/2019 by the undersign in presence of Rajendra Singh Mertia, Mine Manger and Sri Pranjal Bhatnagar, Geologist of your Mine:
