13(1):	The mining operations were carried out in violation of following provisions of approved modified Mining Plan (approved on 21.02.2014): -
	(i) In Para 5.0 during the in year 2014-15 the production of lime stone was proposed 60,000 tonnes but actual production achieved 73,413.3 tonnes up to 31st Dec. 2014 for the year 2014-15.

- 02. However the reply furnished by you in compliance of Rule13 (1) & 45(1)(a) was duly considered so compliance of Rule 45(1)(a) has been considered but the reply for the rule 13(1) was not found satisfactory.
- 03. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988.
- 04. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
- You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to 05. why you should not be prosecuted for the above offences.
