महोदय,

The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 12.03.2015 by the undersigned in presence of Shri Bahadur Singh, Partner of firm and based on available office record.

Rule No.	Nature of violation observed in detail
45(5)	The owner, agent, mining engineer or manager of every mine, shall submit to the regional controller of Mines in Indian Bureau of Mines or any other authorized official of the Indian Bureau of Mines, returns in respect of each mine in the following manner, namely:
45(5)(a)	A monthly return which shall be submitted before the 10 th of every month in respect of preceding month in the Form F-8. However it is observed that, you have not submitted monthly returns since April 2014 to this office..
45(5)(b)	An annual return which shall be submitted before the 1 st July each year for the preceding financial year in the Form H-8. However it is observed that, you have not submitted annual returns for the year 2011-12, 2012-13 & 2013-14 to this office.

These violations may lead to suspension of all mining operations in the mine as well as termination of mining lease and prosecution of the owner, agent and manager.

02. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988
03. You are therefore, directed to show-cause within a period 30 days from the date of the issue of this letter as to why mining operations in your above mine should not be suspended in accordance to rule 45(7) of MCDR 1988.
04. Please note no further notice will be given to you in this regard.
