The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection made on 22.01.2015 by the undersigned in presence of Shri Ajay Purkastha, Mine Manager

Rule No. Nature of violation observed in detail

13(1):

The mining operations are carried out in violation of following provisions of approved Scheme of Mining (approved on 13-04-2011): -

- In Para 3.4.2 Exploration was proposed by two boreholes in Western Block in I year(2011-12) & III year(2013-14) and one bore hole in Eastern Block in IV year(2014-15) but no such exploratory boreholes have been drilled.
- (ii) In Para 5.0 it was proposed that mining shall be carried out by formation of benches 6m in height but in western block bench height was observed more than 8m height.
- (iii) No effective preventative measures have been taken to prevent roll down the waste material into natural drainage.
- In this connection, it is brought to your notice that the above violations constitute an offence punishable under 02. Rule 58 of MCDR, 1988.
- 03. The mining operation can be suspended under rule 13(2) of MCDR 1988 if compliance of rule 13(1) of MCDR 1988 is not found satisfactory.
- You are, therefore, directed to show cause within a period of 30 days from the date of issue of this letter, as to 04. why you should not be prosecuted for the above offences. 05.
