The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 26/05/2013 by the undersigned:

Rule No.	Nature of violation observed in detail
13(1)	The mining operations are carried out in violation of following provisions of approved Scheme of Mining (approved on 09-06-2011): - 1) During the inspection the bench height was found more than 7m in Pit L-1 to L-8, While it should be 6m.
45(1) (a):	No Monthly returns received to this office since October 2011.

01. In this connection, it is brought to your notice that the above violations constitute an offence Punishable under Rule 58 of MCDR, 1988 and suspension of mining operation under rule 13(2) of MCDR 1988
02. You are therefore directed to show cause within 30 days from the date of issue of this letter as to why your mining operation should not be suspended under Rule 13(2) of MCDR 1988 and You should not be prosecuted under Rule 58 of MCDR 1988
03. Please note that no further notice will be given to you in this regard.
