Subject: Violation of provisions of MCDR, 1988 in respect of your Appalanasimhapuram Iron Ore Mine in Khammam District, A.P. State over an extent of 6.87 ha.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 (Amended in 2011) were found violated in your above mine on during the inspection during inspection on 23.05.2015 by Sri A.V.Ramesh Kumar, Assistant Mining Geologist of this office accompanied by your representative Sri Anand.

Rule No.	Nature of Violation
12(3)	The scheme of mining should have been submitted to the Competent authority i.e. Regional Controller of Mines, Indian Bureau of Mines, Hyderabad at least one hundred twenty days before the expiry of the five years period, for which it was approved on the last occasion. The Scheme of Mining for the Mine was approved on 01.02.2012 valid up to 31.03.2013. No Scheme of Mining was submitted to the competent authority i.e. Regional Controller of Mines for the subsequent periods.
13(1)	Mining operations should have been undertaken in accordance with the approved Mining Plan/Scheme of Mining. Since you have no approved Scheme of Mining for your above mentioned Mine, it is evident that the mining operations are not being carried out in accordance with the approved Scheme of Mining.

02. It is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rule 13(1) is also liable for suspension of mining operations under rule 13(2) of MCDR, 1988.

03. You are, therefore, directed to **show-cause** within a period of 30(thirty) days from the date of issue of this letter, as to why you should not be prosecuted for the above offence and or Mining operations shall be suspended under the provision of Rule 13(2) of MCDR, 1988 in the Mine till the compliance of the aforesaid violation.

04. Please note that no further notice will be given to you in this regard
