	(ii) In Para 10.4 it was proposed to plant 100 saplings in each year 2012-13 & 2013-14, but the same has not been planted.
45(1) (a):	Monthly returns of the mine for the month June 2011, December 2011, April 2012, May 2012 & June 2013 have not been submitted to this Office.

02. In this connection, it is brought to your kind notice that the above violations constitute an offence punishable under Rule 58 of MCDR, 1988 & may lead to suspension of mining operation under rule 13(2) of MCDR 1988.
