Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your New Umrangshu Limestone Mine (38ASM08003) over an extent of 35.00 Ha. in Umrangshu Village, Taluka- Umrangshu, Dima Hasao district of Assam State.

Sir,

On perusal of office record a violation letter of even number dated 03.10.2019 was issued for below mentioned rules of Mineral Conservation & Development Rules, 2017.

Rule Number	Nature of violations observed
11(4): The holder of a mining lease shall submit the mining plan to the competent authority for review at least 180 days before the expiry of 5 years period for which it was approved on the last occasion, for mining operations for a period of 5 subsequent years.	<p>The existing review of mining plan in respect of your New Umrangshu Limestone Mine over an extent of 35.00 Ha. in Dima Hasao district of Assam State is valid upto 31.03.2020 and the next review was due for submission on 02.10.19.</p> <p><i>In response to the violation letter, you have submitted your compliance vide letter dated 11.11.2019 that, you have submitted the draft copy of review of mining plan by DTDC courier vide receipt No. K22283558, dated 11.11.2019. The hard copy of the review of mining plan was received in this office on 13.11.2019 and the same was processed. Further this office has issued a letter of scrutiny comments and submission of final three hard bound copies of text and plans along with requisite bank guarantee as financial assurance within 15 days from the date of issue of the letter on dated 19.11.2019.</i></p> <p><i>But, even till end of office hours of 05.12.2019, the final three hard bound copies of text and plans along with requisite bank guarantee as financial assurance has not been submitted to this office.</i></p> <p><i>Accordingly, dis-approval letter of the submitted draft review of mining plan has been issued vide letter dated 05.12.2019 and therefore the violation pointed out vide letter dated 03.10.2019 stands valid.</i></p>


02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are therefore directed to show cause within a period of 30 (Thirty) days from the date of issue of this letter, as why you should not be prosecuted for the above offences.

5. Please note no further notice will be give to you in this regard.
