**Subject:** Violation of provisions of Mineral Conservation and Development Rules, 2017, Langumshing Sillimanite Mine (55MEG05001) over an area of 4.64 Hect. in Langumshing Village, Taluka- Nongstoin, West Khasi Hills district of Meghalaya.

Sir,

On perusal of the office records, the following provision of MCDR, 2017 was found violated in your above mine.


Rule Number	Nature of violations observed
11(4): The holder of a mining lease shall submit the mining plan to the competent authority for review at least 180 days before the expiry of 5 years period for which it was approved on the last occasion, for mining operations for a period of 5 subsequent years.	The existing review of mining plan in respect of your Langumshing Sillimanite Mine over an extent of 4.64 Ha. in West Khasi Hills district of Meghalaya is valid upto 31.30.2020 and the next review was due for submission on 02.10.2019.  But, till date no draft review of mining plan has been submitted to this office for its perusal.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
