Sub: Violation of provisions of Mineral Conservation & Development Rules, 2017, in respect of your Manakudaiyan (South of South )Limestone Mine over an area of 44.80.5 Ha in Manakudaiyan Village, Sendurai Taluk of Ariyalur District.

Sir,

The following provisions of the Mineral Conservation and Development Rules, 2017, were found violated in your above mine during the inspection on 30/07/2021 by the undersigned in the presence of Mr. J.Ravi Sr Manager (Mines)& Mr M.R.Venkatesan GM (Mines):

Rule No.	Nature of Violation
11(1)	Mining operations have not been carried out in accordance with the Approved Scheme of Mining approved vide Letter No. TN/ALR/LST/ROMP-1439.MDS dated.06.11.2017 and TN/ALR/LST/MMP-2070.MDS dated 11.01.2021 to the extent indicated below:  <i>(i) There was a proposal to produce 15,42,544 tonnes of Limestone in the year 2020-21, against the approved proposal only 9,25,002.67 tonnes of Limestone was produced during the said year.</i>  <i>(ii) There was a proposal to undertake plantation under afforestation 1500 number of samplings in the year 2020-21, against the approved proposal carried-out only 1000 plantation in the said year.</i>

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

03. The mining operation can be suspended under Rule 11(2), if the compliance of Rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
