विषयः Violation of provision of Mineral Conservation and development rule 2017 in respect of your Rampura-Agucha Lead-Zinc Mine in Bhilwara district of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 24/11/2020 and 25/11/2020 by Sri B.L. Kotriwala, Regional Controller of Mines and undersign in presence of your good-self and Sri Ranjan Gupta, Geologist of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modification in Review of Mining Plan approved on 27/03/2018 to the extent given below: (1) It was observed during mine inspection that a total of 31831 mts of horizontal and vertical development has been carried out against the target of 38695 mts of horizontal and vertical development of the year 2019-20.
26(2)	The yearly report on extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the Regional Controller of Mines (competent authority) for the year 2019-20.
35(2)	As specified in the rule, soft copy (in the standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map as specified in the Rule has not been submitted to the Regional Controller of Mines, Ajmer.
45(7)	On examination of annual return for the year 2019-20 following discrepancies have been observed. (1) Part V, section 7: During inspection it was reported that Pb-Zn Ore is being feed to the beneficiation plant located within lease boundary. However, details required under section 7 of part V in connection with beneficiation plant have not been furnished. (2) Rule 45(8)(b)(V): As per rule the ex-mine price for the captive mine is per unit cost of production. However, in annual return the cost of production has been furnished as Rs. 8155.10 per Tonne and the Ex-mine furnished is Rs. 2814.52 per Tonne.
