विषय: Violation of provision of Mineral Conservation and development rule 2017 in respect of your Baroi Lead-Zinc Mine in Udaipur district of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 24/10/2020 by undersign in presence of Sri Vinod Kumar Saini, Mining Engineer and Sri Shashi Bhushan Shukla, Head Geology of your Mine:

| Rule  | Status and extent of violation   |

| 11(1) | Mining operations have not been carried out in accordance to Modified Mining Plan approved on 17/05/2019 to the extent given below:<br>(1) During year 2019-20, a total of 609 exploratory bore holes with 55000 mts of drilling were proposed. However, during inspection it is reported that only 460 bore holes with 88645 mts of drilling has been carried out. Deviation has been observed in the number of drill holes drilled.<br>(2) As per approved document plantation has been proposed in Pratap Pura area between grid 8020 E to 8610E and 12780N to 13580 N. However, it is observed that plantation has not carried out over proposed area.   |
| 26(2) | The yearly report on extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the Regional Controller of Mines (competent authority) for the year 2019-20.   |
| 35(2) | As specified in the rule, soft copy (in the standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map as specified in the Rule has not been submitted to the Regional Controller of Mines, Ajmer.  |
| 45(7) | On examination of annual return for the year 2019-20 following discrepancies have been observed.<br>(1) Part-I, Section-12: The details/area of the "work done under progressive mine closure plan during the year" has not been furnished.<br>Part II A: The value of fixed asset has been furnished as '0' (Zero). However, during inspection infrastructure and other fixed asset has been observed.<br>(2) Part V, section 7: During inspection it was reported that Pb-Zn Ore is being feed to the beneficiation plant located in Mochia Mine boundary. However, details required under section 7 of part V have not been furnished.<br>(3) Part VII (cost of production): Cost of exploration has not been furnished, whereas exploration details have been furnished in part V, section-4. Cost of beneficiation has also not been furnished. Further, amount paid towards NMET and DMF has not been considered for cost of production calculation. |


(4) Rule 45(8)(b)(V): As per rule the ex-mine price for the captive mine is per unit cost of production. However, in annual return the cost of production has been furnished as Rs. 3480.83 per Tonne and the Ex-mine furnished is Rs. 3314.95 per Tonne.

02. Further, this to bring in your kind notice that no reply yet has been received in respect of the violation issued vide this office letter of even number dated 03/12/2019.

03. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों का उल्लंघन की अनुपालना नहीं होने पर खनिज संरक्षण एवं विकास नियमावली, 2017 के अंतर्गत :

- (क) आपकी खदान की सारी संकियाएं बंद की जा सकती है।
- (ख) आपके विरुद्ध अभियोग दायर किया जा सकता है।
- (ग) राज्य सरकार को खनन पट्टे की समिति की सिफारिश।

04. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैंतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
