विषय: Violation of provision of Mineral Conservation and development rule 2017 in respect of your Kayad Lead-Zinc Mine (16/92) over an area 480.45 Ha. in Ajmer district of Rajasthan State.

महोदय,

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 18/08/2020 and 19/08/2020 by undersign and Sri Rajani Kanta Rautaray, AME in presence of Sri Anshul Khandelwal, Mine Manager, and Vijendra Kashyap, Geologist of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modified Mining Plan approved on 06/09/2019 to the extent given below: (1) During year 2019-20, a total of 80 exploratory bore holes with 12000 mts were proposed from underground. However, during inspection it is reported that only 66 bore holes with 6314 mts has been drilled from underground. (2) The most of the exploratory drilling (refer plate no M12) proposed for the year 2019-20 for S1 lens between 450 mRL and 200 mRL and Main lens between 150 mRL and -200 mRL has not been carried out as per proposal. The exploratory drilling carried out during the year 2019-20 between 400 mRL to -300 mRL (K18 lens area) has a proposal for the year 2020-21, resulting deviation in the proposed location of exploratory bore holes for the year 2019-20. (3) As per approved document plantation for the year 2019-20 has been proposed over two locations bounded with grid lines N10280-10460/E1035-1175 (location 1) and N10392-10475/E1390-1530 (location 2). During inspection it is observed that plantation proposed over location 1 has not been carried out and instead of location 1 planation has been carried out near boundary pillar H & Orica and behind admin building & scrape yard. Resulting deviation in plantation location for the year 2019-20.
26(2)	The yearly report on extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the Regional Controller of Mines (competent authority) for the year 2019-20.
35(2)	The soft copy (in the standard format), of high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map as specified in the Rule has not been submitted to the Regional Controller of Mines, Ajmer. However, on check of soft copy of satellite image provided during mine inspection it is observed that two kilometer boundary from mining lease has not been depicted on the image.

45(7)	<p>On examination of annual return for the year 2019-20 following discrepancies have been observed.</p> <p>(1) In part V, Para 4 – Mining operation during the year: During inspection it is reported that a total of 117 exploratory bore holes with 35728 meters of drilling were carried out in the year 2019-20. However, in annual return 112 bore holes with 32796 meters of drilling has been furnished.</p> <p>(2) Rule 45(8)(b)(V): As per rule the ex-mine price for the captive mine is per unit cost of production. However, in annual return the cost of production has been furnished as Rs. 4352.00 per Tonne and the Ex-mine furnished is Rs. 1326.00 per Tonne.</p>

02. इस संदर्भ में आपका ध्यान आकर्षित किया जाता है कि उपरोक्त नियमों का उल्लंघन खनिज संरक्षण एवं विकास नियमावली, 2017 के नियम 62 के अंतर्गत दंडनीय अपराध है एवं उपरोक्त नियमों का उल्लंघन की अनुपालना नहीं होने पर खनिज संरक्षण एवं विकास नियमावली, 2017 के अंतर्गत :

- (क) आपकी खदान की सारी सक्रियाएं बंद की जा सकती हैं।
- (ख) आपके विरुद्ध अभियोग दायर किया जा सकता है।
- (ग) राज्य सरकार को खनन पट्टे की समिति की सिफारिश।

03. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुधार करें एवं इसके सुधार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैंतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
