विषयः Violation of provision of Mineral Conservation and development rule 2017 in respect of your Maliakhera Limestone Mine (04/2003), over an area 315.409 Ha. in Chittorgarh district of Rajasthan State.

महोदय.

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above said mine during inspection on 8/10/2020 and 9/10/2020 by undersign in presence of your good-self, Sri Dilip Kumar Dhakar, Mine Manager, and Sri Rajneesh Kothari, Geologist of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Modified Mining Plan approved on 29/11/2018 to the extent given below:  (1) During year 2019-20, a total of 28 exploratory bore holes were proposed to drill, however, during inspection it is reported that only 07 bore holes were drilled during the year 2019-20.
26(2)	The yearly report on extent of protective and rehabilitative works carried out as specified in the rule has not been submitted to the Regional Controller of Mines (competent authority) for the year 2019-20.
45(7)	On examination of annual and monthly returns from 2017-18 to 2019-20, the following discrepancies have been observed in reporting of cement grade limestone figures -:  (i) The closing stocks in monthly return of March-2018 and annual return of 2017-18 is reported as "0" tonnes whereas the opening stock in annual return of 2018-19 is reported as 1143910 tonnes.  (ii) The closing stock in monthly return of March-2019 is reported as 202881 tonnes whereas the closing stock in annual return of 2018-19 is reported as 1346791 tonnes. Further, the closing stock of annual return for 2018-19 is not matching with opening stock of monthly return for April, 2019.  (iii) The closing stock in monthly return of March-2020 is reported as 300581 tonnes whereas the closing stock in Annual return of 2019-20 is reported as 1444490.98 tonnes.  (iv) The total production as per monthly returns from April-2019 to March-2020 is 2530235.65 tonnes whereas the total production in annual return of 2019-20 is reported as 2545016.86 tonnes.  (v) Part I, Para 12 (Annual return 2019-20): The land use details furnished at the end of the year 2019-20 is not matching with approved Review of Mining Plan dated 25/11/2019.

(vi) In part VI, Para 1(Annual return 2019-20): Sub-grade Limestone generation of 97700 tonnes has been reported under part V, section 4 whereas same has not considered under ROM production.

(vii)Part-VII (Annual return 2019-20): As per part IIA an interest of Rs. 2135384607 was paid, whereas same has not been considered under cost of production. Further, amount paid towards DMF and NMET has also been not considered for estimation of cost of production.

The aforesaid discrepancies show gross irregularities in reporting of figures and illegality in mining.

(क) आपकी खदान की सारी संक्रियाएं वंद की जा सकती है।

(ख) आपके विरुध्द अभियोग दायर किया जा सकता है।

(ग) राज्य सरकारा को खनन पट्टे की समप्ति की सिफारिश।

03. अतः आपको सलाह दी जाती है कि आप उपरोक्त उल्लंघनों का अतिशीघ्र सुघार करें एवं इसके सुघार की स्थिति की सूचना इस पत्र के जारी होने की दिनांक से 45 (पैतालिस) दिनों के भीतर इस कार्यालय को सूचित करें।
