Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017 in respect of Kalne Iron & Manganese Ore Mine, Lessee- Minerals & Metals, over an area of 32.25 ha. situated in Kalne Village, Dodamarg Taluka, Sindhudurg District of Maharashtra State.

The following provisions of the Mineral Conservation and Development Rules, 2017 were found violated in your above mine during the inspection on 01.02.2022 by Shri. Vidyadhar V. Tari, Asstt. Mining Engineer of this office in presence of S/shri. Suresh Kulal, V.P (Operations), Amit Kaisukar, Mines Manager and Pradeep Kr. Doki, Surveyor.

Rule No.	Nature of Violation observed
27(1)&(2)	As per MCD (Amendment) Rule, 2021 notified on 03.11.2021, lessee is required to deposit a financial assurance of five lakh rupees per hectare of the mining lease area put to use for mining and allied activities in respect of Category "A" mine. However, requisite difference in financial assurance amount in the form of Bank Guarantee is not found submitted to this office so far.

02. In this connection, it is brought to your notice that contravention of rule 27 shall be punishable with imprisonment or with fine, or with both as per the provisions of Rule 62(1) of MCD (Amendment) Rules, 2021 notified on 03.11.2021.
