Sub:- Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of your Awaradi Limestone Mine (ML.No.2412), Area-4.08Ha situated in Awaradi village, Gokak Taluka, District Belgaum of Karnataka State.

The following provisions of Mineral Conservation & Development Rules, 1988 were found violated during the inspection of your above mine on 28/04/2014 FN by the undersigned.

Rule	Nature of Violation Observed
13(1)	The mining operations are not carried out as per approved scheme of mining on 12.4.11 to the extent indicated below. Exploration- It was proposed to drill 02 No. of core drill holes up to 30m depth each in third year of scheme period i.e. 2010-11 as earmarked in plate no.4 but it has not been done & intimated to this office till date.
12(3)	The last scheme of mining was approved vide letter No. MSH/MAN-209(KNT)/GOA/2010-11 dated 12/04/2011 for the period of 2008-09 to 2012-13, As such scheme of mining had fallen due for submission on 01.12.2012 for the next five year period has not been submitted for approval to the Regional Controller of Mines, IBM Goa so far.
45(5)(b)	An annual returns for the year 2012-13 which shall be submitted before the 1 st July of the preceding financial year in the prescribed form-H-8 but it has not been submitted to the Regional Controller of Mines, Indian Bureau of Mines Goa so far.
24(1)	Mining operations in the lease area were found temporarily closed from more than 3 years but the notice in form D-1 has not been submitted even after more than 90 days from temporary discontinuance to IBM Goa office.

- 02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.
- 03. Further the violation of Rules 12(3) may also attract the provision of rule 13(1) & 45(5) of MCDR may also attract provisions of Rules 13(2) & 45(7)(1) of MCDR 1988 regarding suspension of mining operations till the compliance of violation.
- 04. You are therefore, directed to show cause within a period of thirty (30) days as to why you should not be prosecuted for the above offence and/or why mining operations shall not be suspended as per provision of Rule 13(2)/45(7)(1) of MCDR, 1988 or legal action may be initiated.
- 05. Please note that no further notice will be given to you in this regard.
