The following provisions of Mineral Conservation & Development Rules, 1988 were found violated during the inspection of your above mine on 18/8/2014 by the undersigned.

Rule	Nature of Violation Observed
23(E)(2)	A yearly report before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted to this office.
46	A full time Mining Engineer & Geologist have been appointed to S/Shri Pandey M.S.Prasad, Diploma in mining & first class managers certificate & C.M.Sudi, MSc. Geology respectively but notice in form-I is not submitted to IBM Goa till date.
63	A Self-Appraisal Report to be submitted by Owner of the mine under Rule 63 of MCDR, 1988 stating extent of implementation of Approved Mining Plan/Scheme of Mining during the year of 2013-14 along with supporting plans/sections, representative photographs in hard as well as soft copy has not been received in this office.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.

03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
