**Sub : Violation of provisions of Mineral Conservation & Development Rules, 1988 in respect of Your Dhawaleshwar Dolomite Mine M.L.No-2282, Area-4.86 Ha. situated in Dhawaleshwar Village, Gokak-Taluka Distt.-Belgaum, Karnataka-State**

Dear Sir,

The following provision of Mineral Conservation & Development Rules, 1988 was found violated during the inspection of your above mine on 20/11/2014,by the undersigned.

Rule	Nature of Violation observed
13(1)	<p>The mining operation in the lease area are not carried out as per approved mining plan/scheme of mining and following deviations are observed during inspection.</p> <p><b>1)</b> As per the approved Scheme of Mining for the period 2010-11 to 2014-15, there was a proposal to produce 5000 tons of Dolomite /year between the co-ordinates 165 N to 207N &amp; 98E to 178 E (Refer Drg No-6). However during field inspection it was observed that 3 pits were developed &amp; are not developed as per the proposals. Pit No-1 was developed b/w co-ordinates 230N to 240N &amp; 220E to 250E, Pit No-2 developed b/w co-ordinates 150N to 170N &amp; 220E to 240E &amp; Pit No-3 developed b/w 150N to 160N &amp; 60E to 75E.</p> <p><b>2)</b> In chapter 4 , point No 5 of approved scheme of mining it was proposed to drill 2 Core drill holes, upto a depth of 30m in the year 2011-12 . during inspection it was noticed that no such exploration work has been carriedout in the mine.</p> <p><b>3)</b> In chapter 9 of approved scheme of mining it was proposed to plant 200 plants in the western part of the lease boundary within 7.5 safety zone(Ref Drg No-6) .During inspection it was observed that only 20-30 coconut plantation was made in the north eastern part of the lease.</p> <p><b>4)</b> In the chapter No 6 of approved scheme of mining it was proposed to dump waste b/w the co-ordinates 56N to 102N &amp; 68E to 104E(Ref Drg No-6). During inspection it was observed that dumping was made in the other lease of the same lessee bearing M.L.No-2298 which is adjacent to the lease.</p>

23(E) 2	An yearly report on PMCP before 1 <sup>st</sup> July of every year setting forth the extent of protective and rehabilitation work carried out as envisaged in the approved progressive mine closure plan has not been submitted.
25	intimation in Form-C of reopening of a mine after temporary discontinuance, is not sent to this office so far.
42 (i) (ii)	A whole time or part time Geologist and Mining engineer have not been employed as prescribed under sub clauses of the said rule.
45(5)(a)	A Monthly returns for the Month of September & october-2014, which shall be submitted before 10th of every month in respect of preceding month is not submitted to this office so far.
63	A self appraisal note to be submitted by the mines owner/lessee stating extent of implementation of approved minig plan/scheme of mining during the year 2013-14 along with supporting plan & sections ,representative photographs is not submitted to this office so far in hard as well as soft copy.

02. In this connection, it is brought to your notice that the above violation constitutes an offence, punishable under Rule 58 of MCDR, 1988.

**03. Further the violation of Rule 13 (1) of MCDR may also attract provisions of Rule 13 (2) of MCDR 1988 regarding suspension of mining operations till the compliance of violation.**

04.You are advised to rectify the above violation immediately and intimate the position to this office within 45 (Fourty five) days from the date of issue of this letter.
