Violation of provision of Mineral Conservation & Development Rules, 2017 in respect of your Lampiya Iron Ore, Copper and Associate Minerals Mine over an area of 433,1033 Hect. in Bhilwara District of Rajasthan State.

महोदय

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found to violated in your above said mine during inspection on 14 April 2021 by the undersigned in presence of your good-self, Shri Sanjay Kumar Pandey, Mine Manager and Shri Divakar Arora, Geologist of your Mine:

Rule	Status and extent of violation
11(1)	Mining operations have not been carried out in accordance to Review of Mining Plan approved on 20/01/2020 to the extent given below for the year 2020-21: (1) Ore to Overburden ratio (stripping ratio) was achieved 1:0.62 (CuM/CuM) against the proposed ratio of 1:0.43 (CuM/CuM). (2) It was proposed to maintain height and width of the benches at 8 to 10 and 15 meters respectively. However, it is observed that height and width of the benches have not been maintained as per approved proposal. (3) The mineral stacking was proposed between grid lines N2814540 to 2814425/E463790 to 463940. However, mineral stacking was observed other than the proposed limit between N2814430 to 2814580/E463800 to 464120 and N2814140 to 2814220/E463340 to 463420. (4) Retaining wall of 320 mts proposed along the foot of waste dump has not been constructed. (5) Plantation proposed over 1.0 hect, with 1000 number of plants has not been carried out.
45(7)	On examination of annual return for the year 2019-20 following discrepancies have been observed. (1) Part V, Section 1: The grade of mineral reject has been mentioned as 13%. However under section 4 quantity of mineral reject generation has been mentioned as "Zero" or NIL Further, during mine inspection also no mineral reject generation was reported. (2) Part VII: Exploration work has been reported as NIL under part V, Section 4. However Rs. 10.26 per tone of exploration cost has been considered under cost of production. Further Rs. 3.83 per tone depreciation cost has been considered under cost of production, whereas value of fixed asset has been furnished as NIL or Zero. The transportation cost Rs. 195.06 per tone considered under cost of production is too high.
