Sub: Violation of provisions of Mineral Conservation and Development Rule, 2017 in respect of your Roida-C Iron and Manganese Ore Mine, over an area of 192.81 hectare in Keonjhar district of Odisha State.

The following provision of Mineral Conservation and Development Rules, 2017 (hereinafter referred as MCDR, 2017) was found violated in your above said mine during inspection on 30.08.2018 by the undersigned and Sri Dilip Jian, Junior Mining Geologist, of this office. The said inspection was accompanied by Sri Mr. Yudhisthir Mahanta, Mines Manager and Sri Sumanta Sahu, Geologist of your mine.

11(1)	No holder of a mining lease shall commence or carry out mining operations in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Government pursuant to the proviso to clause (b) of sub-section (2) of section 5,limits declared under Schedule-A of the Atomic Minerals Concession Rules, 2016.	30.12.2016 to the extent given below: A total of 16 exploratory bore holes were proposed to drill during the year 2017-18. However, it is observed that no exploratory bore holes have been drilled during the year

- 02. It is brought to your notice that above violations of MCDR, 2017 constitutes an offence punishable under Rule 62 of MCDR, 2017. Besides, inability to comply the provision of rule 11(1) is also liable for suspension of mining operation under the provision of rule 11(2) of MCDR, 2017 respectively.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.
