Subject: Violation of provisions of Mineral Conservation and Development Rules 2017 in respect of your Pandapuli Limestone mine over 4.09.5 ha in SF nos; 24/1F 29/2B etc. in Pandapuli Village, Sankarankoil taluk, Tirunelveli district, Tamilnadu State.

The following provisions of Mineral Conservation and Development Rules 2017, were found violated in your above mine during the MCDR inspection on 01/08/2017 by Sri.N.Subrahmanyam Assistant Mining Engineer of Indian Bureau of Mines, Chennai in presence of your representative Mr. Radhakrishnanr.

RULE No	NATURE OF VIOLATION
Rule-33	<u>Copies of plans and sections to be submitted.</u> The holder of mining lease shall on or before the 30 th day of June every year submit to the authorised officer, as the case may be, and the State Government, a digital copy along with a print copy of the surface geological plans and sections maintained under rule 32. But, this office has not received the updated surface geological plan and sections as required under rule.
Rule 54(d)	<u>Copies of notices and returns and reports to be maintained:</u> The holder of mining lease shall maintain the labour attendance register, production and dispatch register, royalty assessment register. Details of mining machinery and copies of all notices and returns, plans, sections and schemes submitted to Regional Controller of Mines, Indian Bureau of Mine, and Chennai. Has not been maintained.
55(1) (c) (ii)	A part time mining engineer and mining geologist should be employed in the case of category B mines under these rule. No part time mining engineer and mining geologist have been employed in your mine.
