Sub: Violation of provisions of MCDR, 2017 in respect of your Jaggayyapeta Limestone Mine over an extent of 1295.00 ha. situated in Budawada Village, Jaggayyapeta Mandal, Karishna District of Andhra Pradesh State.

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 01/09/2021 by the undersigned in presence of the mine officials Shri K. K. Dhruvw, Mining Engineer and Shri K. Srinivas Rao, Geologist.

Rule No.	Nature of violation
Rule 11 (1)	The following deviations have been found in the mine from the approved Modified Mining
	Plan vide letter no. AP/KSN/MP/LST-7/HYD Hyderabad dated 26/05/2020 for the period
	of F.Y. 2020-21 to 2024-25:
	Exploration: During F.Y. 2020-21 and F.Y. 2021-22; it was proposed to drill 10 nos. of
	boreholes with the cumulative depth of 917.0 meters, whereas, none of the boreholes have
	been drilled so far.
Rule 26 (1)	During inspection, it has been found that an old worked out pit/quarry situated in between
	UTM Co-ordinates N680000 to N680500 and E2750500 to E2751000 within lease area is
	left abandoned. The mineral was mined out earlier, and later no Protective Measures was
	taken around this quarry. Hence, suitable Protective Measures should be taken around this
	non-working quarry.
Rule 45 (7)	Annual Return F.Y. 2020-21:
	Part - VI (Production, Dispatches And Stock): For Captive Users, Ex-mine price should be
	reported similar to the Cost of Production as computed in Part VII.

- 02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence punishable under Rule 62 of MCDR, 2017.
- 03. The mining operations can be suspended under rule 11(2) and 45(7), if compliance of rule 11(1) and 45(7) are not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
