Subject: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Umsoo-Mootang Block-II limestone mine over a total extent of 4.9 Ha. in East Jaintia Hills Distt of Meghalaya State.

The following provisions of the MCDR, 2017 were found violated in your above mine during the inspection on 9th Sept. 2018 by the undersigned in presence of your mine officials Shri Sanjay Kumar, Agent-Mines.


Rule Number	Nature of violations observed
45(1) - The holder of a mining lease or any person or company engaged in trading or storage or end use or export of minerals mined in the country shall cause himself to be registered online with the IBM as per application specified in Form-K of the schedule.	M/s Adhunik Cement Ltd. was registered with IBM registration No. 6395. The agent of mine vide his letter dtd. 19.5.2018 has informed the change in the name of the mine as the company i.e. Adhunik Cement Ltd. has merged with its holding company i.e Dalmia Cement Bharat Ltd. w.e.f 16.5.2018. But, the monthly returns submitted thereafter are still being submitted in the IBM registration No. accorded to M/s Adhunik Cement Ltd. You are advised to submit the monthly returns through the IBM registration No. accorded to M/s Dalmia Cement Bharat Ltd. only.
49 - The holder of a mining lease shall send a notice in Form-C of the schedule to the state govt. and the authorised officer as the case may be of any change in the name of the mine within 30 days of such change.	The cited notice in Form-C was submitted to this office on 19.5.2018 but the name of the old & new nominated owner of the mine were not stated. During the inspection it was informed that Mr. Venkatesan Thyagarajan has been appointed as the new nominated owner for Dalmia Cement Bharat Ltd. , Umsoo-Mootang Block-II mine. You are therefore advised to submit a rectified copy of Form-C to this office immediately along-with a copy of the board resolution regarding appointment of the nominated owner.
34(2) – Every plan, section or part thereof prepared under these rules shall carry thereon a certificate for its correctness and shall be signed by the mining engineer with date.	The surface plans submitted by the lessee vide letter dtd. 30.6.2018 is not correct. During the site inspection carried out by the undersigned, the shown pit configuration is not practically matching with the ground field conditions.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservation and Development Rules, 2017.

03. The mining operations can be suspended under rule 11(2), if compliance of rule 11(1) is not found satisfactory.

04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.


