Sub: Violation of provisions of MCDR, 2017 in respect of your TRB Iron Mines, over an area of 207.113hectare in Sundargarh district of Odisha State

Sir,

The following provisions of Mineral Conservation and Development Rules, 2017 were found violated in your above said mine during inspection on 21.08.2019 by the undersigned accompanied by S/Shri C.Mallick, Senior Inspector of Mines, DDM Office, Koira, State Govt., Of Odisha, P.K.Patra, Agent, B.D.Sahoo, Manager of your mine.

Rule No.	Proposed in the approved mining plan / Rule	Violation
11 (1)	As per the approved mining plan dated 05.12.2018 i) It is proposed to maintain a bench height of 9 m and width of more than 12 m in the patch-2 quarry.	i) During inspection it is observed that the bench height and width are not maintained as per the dimensions proposed in the mining plan proposed in the quarry western side of quarry. and the bench width and height are less than 12 m and 9 m.
45 (7)	Holder of mining lease shall not submit incomplete or wrong or false information in daily or monthly or annual returns.	i) During scrutiny of annual return it is observed that details furnished under Part-III, item no.2(a) as royalty paid information, but during inspection it is observed that it includes payments made to DMF and NMET.

02. It is brought to your notice that these violations constitute an offence punishable under Rule 62 of MCDR,2017.

Besides, inability to comply with the provision of Rule 11 (1) is liable for suspension of mining operations according to the provisions of Rule 11 (2) of MCDR, 2017.

Further, in view of the above position, the information furnished under Rule 45(5) in the Annual return is construed as furnishing wrong or false information, which leads this office to advise the state government under rule 45 (7) to,-


(i) Order suspension of all mining operations in the mine and to revoke the order of suspension only after ensuring proper compliance;

ii) Take action to initiate prosecution under these rules;

(iii) Recommend termination of the mining lease, in case such suppression or misrepresentation of information indicates abetment or connivance of illegal mining;

03. You are advised to rectify the above violations immediately and intimate the position to this office within **45 (forty-five) days** from the date of issue of this letter.
