
Sir,

The following provisions of Mineral Conservation & Development Rules, 2017 (hereinafter referred as MCDR, 2017) were found violated in your above mine during inspection on 08.09.2019 by undersigned accompanied by Shri A.K. Chaudhary, Geologist.

Rule	Nature of Violation observed
35(2)	The high resolution satellite images obtained from CARTOSAT-2 satellite LISS-IV sensor on the scale of cadastral map, as on 31 <sup>st</sup> day of March 2019 for the financial year 2018-19 has not been submitted till date, which ought to have been before 1 <sup>st</sup> July 2019.

2. In this connection, it is brought to your notice that the above violations constitute an offence punishable under rule 62 of MCDR, 2017. Besides, inability to comply the provisions of rule 35(2) also liable for suspension of mining operations under the provisions of rule 11(2) of MCDR, 2017.

3. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty-five) days from the date of issue of this letter.


