Sub: Violation of provisions of MCDR, 1988 in respect of Ogipur Limestone mine over an area of 221.92 ha in ogipur village, Tandur Mandal & Ranga Reddy District, Telangana State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 28.01.2016 by undersigned in the presence of Sri M.Srinivas Reddy, Mines Manager:

Rule No.	Nature of Violation
13(1)	<p>Mining operations should have been undertaken in accordance with the approved Mining Plan/Scheme of mining. The Scheme of Mining was approved vide no. AP/RR/MS/Lst-288-SZ/Hyd on 07.8.2014 for the period 2013-14 and 2017-18 and following deviations observed during the inspection.</p> <p>1. In Para 4.3 seventeen(17 nos), seventeen(17 nos) & seven(7 nos)core boreholes has been proposed for the year 2013-14,2014-15 & 2015-16 respectively but the core drilling was still not started and neither information for starting of drilling received by this office.</p>

02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rules 13(1) is also liable for suspension of mining operations under the provision of Rule 13(2) of MCDR, 1988.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
