Sub: Violation of provisions of Mineral Conservation and Development Rules, 2017, in respect of your Perali(South) Limestone mine over 1.92 hect in Perali (South) village Kunnam taluk , Perambalur district of Tamilnadu State.

Sir,

The following provisions of the MCDR, 2017 was found violated in your above mine during the MCDR inspection by Sri A.S.Sanjeeva Rao, Asst., Mining Geologist on Geologist on 14.07.2017 in presence of your mine officials S/Sri Muthukaruppan, your representative and Balamurugan, Geologist.

Rule No	Nature of Violation observed
26(2)	<u>Submission of yearly report:</u> The holder of mining lease shall submit to the competent authority authority a yearly report as per the format specified by the Indian Bureau of Mines, before 1 st day of July every year setting forth the extent of protective and rehabilitative works carried out as envisaged in the approved mine closure plan, and if there is any deviation ,reasons thereof. But, the yearly report as required under rule has not been submitted to the Regional Controller of Mines.
54(a)	<u>Copies of notices and returns and reports to be maintained:</u> The holder of a mining lease or a holder of a prospecting licence or prospecting license cum mining lease shall maintain the labour attendance register, production and dispatch register, royalty assessment register: (a) Details of contribution made to District Mineral Foundation and National Mineral Exploration Trust; Register as required for District Mineral Foundation and National Mineral Exploration Trust has not been maintained.

02. In this connection, it is brought to your notice that the above violations constitute an offence punishable under Rule 62 of Mineral Conservations and Development Rules, 2017.

03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
