Rule 11 (1)	According to this rule-No holder of a mining lease shall commence or carry out mining operation in any area except in accordance with the mining plan approved, modified or reviewed by the Indian Bureau of Mines or prepared and certified in accordance with the system established by the State Govt. pursuant to the provisions to clause (b) of Sub Section (2) of Section 5 or approved by the competent authority of the Atomic Minerals Directorate for exploration and Researching respect of minerals specified in Part B of the First Schedule of the Act where the grade of such atomic minerals is equal to or above the threshold value limit declared under schedule-A of the Atomic Mineral Concession Rules 2016.
	The Review of the approved of Mining Plan of above mentioned mine was approved vide this office letter No-MP/Chhatarpur/Iron Ore/MPLN/MOD-71/2017-18 dated 12.01.2018. incorporating the proposals for 2020-21. During the inspection it was found that following provisions of rule have been violated.
	 Exploration has not been done against the proposal of 17 numbers of boreholes (12 DTH & 5 Core bore holes) in to the approved plan period. As per proposal, Backfilling has not been done within 7.5m barrier zone between Pillars no BP-6 to BP-5A of the lease area. Check dam not maintained as per approved document.
Rule	The holder of mining lease shall submit a yearly report as per the format specified
26(2)	before 1st July of every year setting forth the extent of protective and rehabilitative work carried out as envisaged in the approved mine closure plan, and if there is any deviation, reason thereof

Employment of geologists and mining engineers. -(1) For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules, -

every holder of reconnaissance permit shall employ a whole-time geologist; every holder of prospecting licence or a prospecting license-cum-mining lease shall employ a whole-time geologist and a part-time mining engineer; every holder of a mining lease shall employ, in case of—

category 'A' mines, a whole-time mining engineer and a geologist;

(b) category 'B' mines, a part-time mining engineer and a part-time geologist:

Provided that in the case of fully mechanised category 'A' mines, the mining engineers and geologists shall have minimum five years of professional experience of working in a supervisory capacity in the field of mining:

- 04) You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty-Five) days from the date of issue of this letter.
