Sub: Violation of provisions of MCDR, 1988 in respect of your Balda Block Iron Ore Mine (335.594 Ha.) in Keonjhar district of Odisha State.

Sir,

On Scrutiny of office records, the following provisions of Mineral Conservation and Development Rules' 1988 were found violated in your above said mine.

Rule No.	Nature of Violation
	(i) In Annual return of year 2009-10, Closing stock of ROM ore from Dump working at mine head reported as NIL. Whereas, in subsequent Annual return of year 2010-11, Opening stock of ROM from Dump working at mine head reported as 1547854.73 Tonnes.
	(ii) In Annual return of year 2009-10, Closing stock of ROM ore from Opencast working at mine head reported as 286042.93 Tonnes. Whereas, in subsequent Annual return of year 2010-11, Opening stock of ROM from Opencast working at mine head reported
45(7)	as 93351.5 Tonnes. (iii) In Annual return of year 2009-10, Closing stock of total processed iron ore of different grades at mine head reported as 286042.93. Whereas, in subsequent Annual return of year 2010-11, Opening stock of total processed iron ore of different grades at mine head reported as 1502738.45 Tonnes. Also, grade-wise closing & opening stocks of Lumps & Fines processed ore were not matching during aforesaid years. (iv) From Annual return of year 2010-11, It is evident that 1469634.92 Tonnes of ROM has been processed. Whereas total production of different grades of processed iron ore reported was 1541546.52 Tonnes, which was more than the quantity of ROM processed.
	(v)In Annual return of year 2010-11, Closing stock of total processed iron ore of different grades at mine head reported as 1604262.38 Tonnes. Whereas, in subsequent Annual return of year 2011-12, Opening stock of total processed iron ore of different grades at mine head reported as 1501620.34Tonnes. Also, grade-wise closing & opening stocks of Fines processed ore were not matching during aforesaid years.

(vi) From Annual return of year 2011-12, it is evident that 1523700 Tonnes of ROM ore has been processed, whereas total production of different grades of processed iron ore reported was only 1456476.85 Tonnes.

The above discrepancies are construed as misrepresentation and suppression of information as per

Rule 45(7) of the Mineral Conservation and Development (Amendment) Rules'2011.

02. In this connection, it is brought to your notice that the above violations constitute an offence

punishable under Rule 58 of MCDR, 1988.

Further, furnishing incomplete or wrong or false information in the returns submitted under Rule 45(5) may lead to suspension of all mining operations in the mine and prosecution of the owner, agent, mining engineer or manager of mine as well as recommendation for termination of mining lease according to provisions of Rule 45(7) of the Mineral Conservation and Development (Amendment) Rules'2011.

- 03. You are therefore directed to show cause within a period of 30 (thirty) days from the date of issue of this letter as to why you should not be prosecuted for the above offence and /or the mining operations should not be suspended in accordance to Rule 45 (7) of the MCDR'88.
- 04. Please note that no further notice will be given to you in this regard.
