Sub: Violation of provisions of MCDR, 1988 in respect of Kirari Limestone mine over an area of 167.048 ha in Kirari village, Akaltara Mandal & Janjgi-Champa District, Chattisgarh State.

Sir,

The following provisions of Mineral Conservation and Development Rules, 1988 were found violated in your above mine during the inspection on 23.05.2016 by undersigned in the presence of Sri Ritesh Kaimal, AGM(Mines).

Rule No.	Nature of Violation
13(1)	 Mining operations should have been undertaken in accordance with the approved Mining Plan. The Mining scheme was approved vide no.314(3)/2011-MCMM(CZ)/MS-51 on 21.6.2013 for the period 2011-12 to 2015-16 and following deviations observed during the inspection. In Para 3.7 fourty (40 nos)core boreholes has been proposed at 75*75m meter grid to a depth of 30 meter in scheme period but actually only 29 boreholes reported. It was proposed to produce 720000 MT of Limestone in 2015-16 but the production is only 275269 MT
42(1)©(i)	For the purpose of carrying out reconnaissance, prospecting or mining operations in accordance with these rules: "Every holder of a mining lease shall employ, in case of category 'A' mines, a full time mining engineer and a full time Geologist". A full time Geologist under this Rule has not been employed.

- 02. In this connection, it is brought to your notice that the above said violations constitute an offence punishable under Rule-58 of MCDR, 1988. Besides, inability to comply the provision of Rules 13(1) is also liable for suspension of mining operations under the provision of Rule 13(2) of MCDR, 1988.
- 03. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
