Subject:- Violation of provisions of MCDR 1988 in respect of your Jambunatha Iron Ore Mine (ML No. 2522) over an extent of 43.91 hect. (As per CEC Survey) in Sandur Taluk of Bellary District (Karnataka)......reg.

Dear Sir,

The following provisions of the Mineral Conservation & Development Rules 1988 were found violated in above mine during the inspection conducted by the undersigned in presence of Shri BV Naidu, Mines Manager on dated 13.11.2015.

Rule 13(1)	Modifications in the Scheme of Mining was approved vide letter No. 279/21/88/BNG dated 08.09.2015. The deviations observed in mining operations vis-a-vis approved document are given below:
	(i) Development work is lagging behind distorting the proposed stripping ratio of 1:1.87 to 1:1.38.
	(ii) The environment data's are not being maintained in a bound paged register.
Rule 21	The HEMM equipment wise log book in respect of each machine as per the provisions under the rule has not found maintained.
Rule 45	Annual return in form H1 submitted for the year 2014-15, reserves figures are incorrect and production cost furnished is on quite higher side.

- 02. In this connection, it is to bring to your notice that the above violations constitute an offence punishable under Rule 58 of MCDR 1988. Further, the violation of Rule 13(1) of MCDR may also attract provision of Rule 13(2) of MCDR 1988 regarding suspension of mining operations till the compliance of the violations.
- 03. You are advised to rectify the above violation immediately and intimate the position to this office within 45 (forty five) days from the date of issue of this letter.
