The following provisions of the Mineral Conservation and Development Rules, 1988 were found violated in your above mine during inspection on 17.06.2015 by the undersigned in presence of S/Shri P.D. Vasanth Kumar Rai, Mines Manager & K. Pakeerappa, Mines foreman.

Rule	Nature of Violations observed
42(1)(i)	No Geologist has been found to be appointed during the course of inspection.
45 (5) (b)(ii)	Following deficiencies are observed in the Annual Return 2014-15: Part I, para 11: Name of the Mining engineer may be corrected as Shri P.D. Vasanth Kumar Rai.
	Part I, para 12: Areas covered under present O/C workings, waste disposal & for mineral stock yard are not found to be furnished correctly.

- 02. It is brought to your notice that violation of the above Rules constitutes an offence punishable under Rule 58 of MCDR, 1988.
- 03. The mining operations can be suspended under rule 13(2), if compliance of rule 13(1) is not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
