Sub: Violation of provisions of MCDR, 2017 in respect of your Ravirala Limestone Mine over an extent of 60.72 ha. situated in Ravirala Village, Jaggayyapet Mandal, Karishna District of Andhra Pradesh State.

The following provisions of Mineral Conservation and Development Rules, 2017 (MCDR, 2017) were found violated in the above mine during the inspection on 08/09/2021 by the undersigned in presence of the mine officials Shri P. Jani Reddy, Agent (Mines).

Rule 11	The following deviations have been found in the mine from the approved Modified Mining
(1)	Plan vide letter no. AP/KSN/MP/LST-2/HYD Hyderabad dated 16/03/2020 for the period of
	F.Y. 2019-20 (01/01/2020) to 2022-23:
	(1) It has been found that as per the approved Modified Mining Plan, 49.65 Ha lease area
	has been considered for calculation of Financial Assurance up to the end of the Plan Period,
	i.e. up to F.Y. 2022-23, whereas, 53.17 Ha. area has been utilized till the end of F.Y. 2020-
	21.
	(2) The overburden and waste material excavated during mining operations should have
	been dumped separately at the designated OB/Waste dump. It is found that the certain
	quantity of limestone and oversize boulders of limestone found in dump with waste
	material.
Rule 45	Annual Return F.Y. 2020-21:
(7)	Part IIA; Capital Structure: 1. Since the furnished value under the section of Fixed Assets
	is for Ravirala Mining Lease (38APR10026) and this value of Fixed Assets is not combined
	with another mining lease, hence, the written Mine Name, Mine Code (38APR10026) and
	Mineral Name should be removed from this section.
	Part V; General Geology & Mining (Sec 1/2 for Limestone); Section 5/6/8/9: Since the
	dewatering is being done from the Pit, hence, the details of the machinery used for
	dewatering should be given in this section.
	Part - VII; Cost of Production: For computation of cost of production, cost of
	transportation from mining lease up to the captive plant should not be added.

02. In this connection, it is brought to your notice that the violation of aforesaid rule constitutes an offence punishable under Rule 62 of MCDR, 2017.

- 03. The mining operations can be suspended under rule 11(2) and 45(7), if compliance of rule 11(1) and 45(7) are not found satisfactory.
- 04. You are advised to rectify the above violations immediately and intimate the position to this office within 45 (Forty Five) days from the date of issue of this letter.
