## Nature of violation observed in details

12(3) The Scheme of mining alongwith Progressive Mine Closure Plan in respect of above mine was approved under rule 12 of MCDR 1988 vide this office letter No. BHD/KYA/715/MS-11, dt. 23.07.2012. The Scheme of mining shall be submitted to the Regional Controller of mines at least one hundred twenty days before the expiry of the five years period, but same has not yet been submitted for approval to the Regional Controller of Mines so far.

Thus this attracts violation of provision of Rule 12(3) of MCDR 1988.

23F. The financial assurance has not been submitted thus attracting the violation of rule 23 F of MCDR'1988.
